Program overview

The **Victorian Aboriginal Business Investment Program** is a new initiative to support the economic growth and sustainability of First Nations businesses.

Aboriginal owned and operated businesses that are based in Victoria and have an economic connection to regional Victoria can apply for funding to help improve their business capabilities and expand their operations.

- Under the *Aboriginal Business Support Program*, grants of between \$5,000 and \$10,000 are available for business support including training and accreditation, mentorship, networking, marketing and access to expert advisory services.
- Under the Aboriginal Business Growth Program, businesses can apply for grants of between \$10,000 and \$100,000 for activities like purchasing new assets, planning and delivering business cases, conducting feasibility studies and technical and specialist training.

- The **Victorian Aboriginal Business Investment Program** will provide grants of up to \$100,000 to help Victorian Aboriginal businesses grow and become more sustainable.
- Aboriginal owned and operated businesses that are based in Victoria and have an economic connection to regional Victoria may
 be eligible to apply.
- Grants of between \$5,000 and \$10,000 are available for Victorian Aboriginal businesses to access resources and services that contribute to their business operations and help them to become more sustainable
- Grants of between \$10,000 and \$100,000 are available for Victorian Aboriginal businesses to invest in resources and activities that enable their growth and development.

Victorian Aboriginal Business Investment Program

The **Victorian Aboriginal Business Investment Program** provides grants to Victorian Aboriginal businesses so they can access resources that will help to sustain or grow their business.

The funding can be used for a range of activities, from marketing, mentorship and accessing expert advisory services to feasibility studies, developing business plans, buying new equipment, or minor building alterations and fit-out.

Eligible businesses can apply for grants through two programs, the *Aboriginal Business Support Program* (grants between \$5,000 and \$10,000) and the *Aboriginal Business Growth Program* (grants between \$10,000 and \$100,000). To be eligible the business must be based in Victoria and have an economic connection to regional Victoria.

Applications are now open and close at 5:00pm on Friday 6 September 2024.

Victorian Aboriginal Business Investment Program

The Victorian Aboriginal Business Investment Program can help businesses to access the resources they need to grow and become more sustainable.

Grants of up to \$100,000 are available for Victorian Aboriginal businesses with an economic connection to regional Victoria. There are two types of funding:

Aboriginal Business Support Program

Grants from \$5,000 to \$10,000 (excluding GST) are available for activities like training and accreditation, mentorship, networking, marketing and access to expert advisory services

Aboriginal Business Growth Program

Grants from \$10,000 to \$100,000 (excluding GST) are available for activities like purchasing new assets, planning and delivering business cases, conducting feasibility studies and technical and specialist training.

Eliaibility

To be eligible for a grant, the business must:

- · be an Aboriginal owned and operated business
- · operate in Victoria
- hold a current Australian Business Number (ABN)
- be registered for GST
- . be registered with the responsible federal or state regulator
- have an economic connection to regional Victoria, such as a presence in regional Victoria, operations that service regional Victoria, or regional suppliers and supply chains.

The Victorian Aboriginal Business Investment Program has grants from \$5,000 to \$100,000 to help Aboriginal-owned businesses grow and become more sustainable.

If your business operates in Victoria and has an economic connection to regional Victoria, you could be eligible to apply.

The funding can be used for a range of activities, including:

- · marketing and promotion
- mentorship
- · accessing expert advisory services
- · obtaining business accreditations
- · product development and testing
- · developing business plans
- · feasibility studies
- · technical and specialist training
- · buying new equipment and machinery.

FAQs

Who can apply?

Aboriginal businesses can apply. The business must be based in Victoria, have an active ABN, be registered for GST, and be registered with the responsible federal or state regulator.

They must also have an economic connection to regional Victoria. This can include either:

- a presence in regional Victoria
- operations that service regional Victoria
- regional suppliers and supply chains.

Applicants must meet the eligibility criteria for each program as specified in the program guidelines.

What is an Aboriginal business?

For this program, an Aboriginal business is one that is at least 51% owned and operated by Aboriginal or Torres Strait Islander people. The guidelines include more information about eligible businesses.

How many grants can I apply for?

Businesses can apply for:

- One grant per ABN in the Business Support Program, and/or
- One grant per ABN in the Business Growth Program.

What can the funding be used for?

Funding in the Business Support Program can be used for activities and expenses like marketing and promotion, mentoring, getting business accreditations, joining networks, business advisory services, and buying equipment and materials.

Funding in the Business Growth Program can be used for activities and expenses like buying new assets and machinery, developing business plans, feasibility studies, specialised training, and minor building alterations and fit-out costs.
