Victorian State Election impact on dates

As the Victorian State election will be held on Saturday 26 November 2022, the Victorian Government will assume a caretaker role from 6.00pm on 1 November 2022 until such time that either it becomes clear that the incumbent government will be returned, or when a new government is commissioned. In line with the caretaker conventions, the incoming government will determine whether to proceed with this grant process and enter into the contract/award the grants after the caretaker period. Applicants should be aware that:

- •all information about this grant process represents the position of the current government only, and is subject to change; and
- •the incoming government may decide to not proceed with this grant process.
